PROCEEDINGS:-

The Chief Engineer/Grid Operation/TANTRANSCO/Chennai among others, has proposed for creation of one post of Executive Engineer/Electrical, Office of the Chief Engineer/Grid Operation/TANTRANSCO/Chennai for considering the grid management in the ensuing summer months and the Chairman/TANTRANSCO has accorded approval of the above proposal.
